



Pay it Forward Award | Terms and Conditions

1. **NOMINEE ELIGIBILITY:** You must be 16 years old or older and a legal United States resident and reside in Ventura County, Los Angeles County, or the Westchase District of Houston, Texas as defined by Premier America Credit Union's Field of Membership. Void where prohibited including outside the Field of Membership.
 2. **NOMINATION PERIOD:** The Nomination Period begins on January 12, 2018 at 8:00 a.m. PT and ends at the end of the campaign, to be determined. Campaign can end or change without notice. Premier America Credit Union (Premier America) will post termination of the campaign at www.PremierAmerica.com.
 3. **TO NOMINATE:** To nominate a person or organization for the Pay it Forward award, complete the form above and hit the submit button. Premier America will review all nominations and dependent on Premier America's sole discretion may award a \$250.00 donation. A Premier America representative will contact you once the submission is received and reviewed using the contact information provided above.
- Premier America reserves the right to disqualify those entries that contain offensive or inappropriate material which are deemed by Premier America to be unsuitable, or which Premier America believes would subject Premier America to a claim or litigation.
- Entrants must use their own name. All entry information becomes the property of Premier America and will not be returned. Incomplete entries will be disqualified.
4. **SELECTION/DONATION RECIPIENT:** Pay it Forward award recipients will be selected by the Premier America Marketing Department and contacted the week they are being recognized, subject to verification and compliance with the rules. If an entrant is selected and cannot be reached by email or telephone after reasonable time and effort is found to be ineligible, or otherwise fails to comply with these Official Rules, that entrant will be disqualified and an alternate winner may be selected from among remaining nominations. The selected charity/group to receive the \$250.00 donation is determined at Premier America's sole and absolute discretion.
